## Who we are?

Noor Educational and Capacity Development Organization (NECDO) is a non-governmental, impartial and non-political organization, registered with Ministry of Economy in 2002 with INO.95. NECDO was established in January 2001 by a group of volunteers to help and support needy Afghan women, youth, and children when the Afghan nation was passing through time-tested moments of its history in Peshawar Afghan Refugee Camps. The destructive civil war resulted in material and spiritual losses for the nation. NECDO started its activities with little means, but greatness of purpose, which was based on humanitarian and development assistance. We believe that unity, faith, proper mobilization of youth & empowerment of Afghan communities can reduce the miseries of the Afghan nation. During our social activities in camps, we realized the need for education, capacity building and income generation projects in order to help our nation with sustainable development; especially educating Afghan women, youth, and children were the priorities set forth; with the believe that it is better to light a candle rather than curse the darkness we initiated several projects and implemented them successfully.

## Mobilizing Afghan Men to Protect Women Rights Democracy and Peace

This project was held previously which contained three workshops for scholars, social activist, women rights activist, government employees, NGO employees, students and other men and women from different areas. These three workshops were held in NECDO main office on (14-July-2016)-(26-July-2016) and (30-July-2016) and the group of youth and government employees were participated in the workshop which was held on 30-July-2016 they were very active majority of them were selected for CWG .

## Trainees Interview

1. Mr. Momtaz Ataei one of youths and student in the third year, journalism faculty of Kabul University, shared his opinions so I learned a lot of topics in this workshop about women's political participation, women's rights, the inheritance right of women and other rights of women. The content of the workshop was very effective. For the sake of preventing violence against women, we apply different practices and learned a lot. Such workshops shall be held for both men and women because it is not only the men who do violence against women, women also do violence against women in this case we had such a great discussion which will be very effective for them. And I gently request this organization to hold such workshops in the future as well because it is very effective.
2. Ahmad Mia Arghandiwal the chairman of the youth team member sports 5<sup>th</sup> zone Deh Sabz district expressed his opinion as such: I learned from mobilizing of afghan men for the support of women's right and peace and democracy that woman can be a Politian, businesswoman, doctor and also a good mother and wife. This workshop is very effective but in one or two day workshops some of the participants may not learn anything. In my opinion such workshops shall be in villages and districts for public awareness. They should know about their rights.
3. Mr. Ahmed Shakeb Darvish, Deh Sabz district youth Chairman has expressed his opinion such, We acquired such a quality and worthy information through this workshop which we did not know before. We are very pleased with this workshop. Because of our high rate of illiteracy in our country, particularly in the provinces and villages, we have many cases of violence against women...

If such workshops are held in villages and provinces for men and women it will be very effective and it will pave the way for peace and democracy as well as it will change the people prospective.

Mr. Abdullwase the Islamic law faculty student and a member of the Youth Union of the students of Deh Sabz, one of the participants of this workshop say: I learned from this workshop that how to stop violence against women who are in such case and make them aware of their rights so that people live in peace. In my opinion the effectiveness of this program will be more if go to the villages and remote areas especially Fridays and teach the people about their rights in mosques and aware them about women and privileges that a woman should have. We thanked this organization for such effective programs.

Mr. Ajmal Khairi whose a bodybuilding trainer from the fifth district have expressed his opinion such: We are very grateful from this organization for conducting such workshops that increase public awareness. The materials we studied in this workshop were very interesting. If such workshops are held in the villages and provinces perhaps it will reduce violence against women cases. And will help the families to stop violence against women. In most families they do violence against women and in my opinion woman is very important in a family if the woman is sad it will affect the whole family members. I believe it is very effective such workshops shall be continued.
